### Immunogen

Peptide with sequence KELKKLEESNEDDC, from the internal region (near the C Terminus) of the protein sequence according to NP\_001990.2.

### Purification and Storage

Purified from goat serum by ammonium sulphate precipitation followed by antigen affinity chromatography using the immunizing peptide.

Supplied at 0.5 mg/ml in Tris saline, 0.02% sodium azide, pH7.3 with 0.5% bovine serum albumin.

Aliquot and store at -20°C. Minimize freezing and thawing.

### Applications Tested

**Peptide ELISA:** antibody detection limit dilution 1:32000.

**Western blot:** Preliminary experiments gave an approx 30-35kDa band in human placenta lysates after 0.3 µg/ml antibody staining. Please note that currently we cannot find an explanation in the literature for the band we observe given the calculated size of 315kDa according to NP\_001990.2. The 30-35kDa band was successfully blocked by incubation with the immunizing peptide.
