Immunogen

Peptide with sequence RKPSDPNRKPNYC., from the N Terminus of the protein sequence according to NP_005976.2.

Purification and Storage

Purified from goat serum by ammonium sulphate precipitation followed by antigen affinity chromatography using the immunizing peptide.

Supplied at 0.5 mg/ml in Tris saline, 0.02% sodium azide, pH7.3 with 0.5% bovine serum albumin.

Aliquot and store at -20°C. Minimize freezing and thawing.

Applications Tested

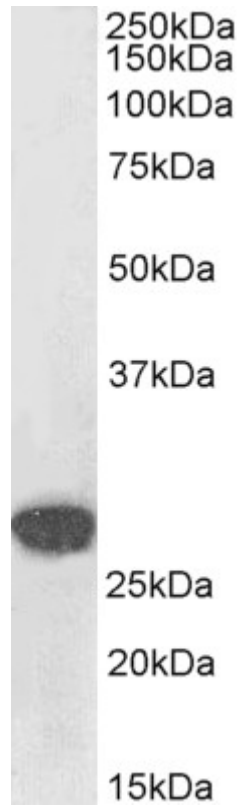
Peptide ELISA: antibody detection limit dilution 1:128000.

Western blot: Approx 28kDa band observed in lysates of cell line A431 (calculated MW of 29.1kDa according to NP_005976.2). See non-biotinylated parental product's datasheet for further QC data. Recommended concentration: 0.03-0.1µg/ml.

Species Reactivity

Tested: Human, Mouse

Expected from sequence similarity: Human, Mouse, Rat



Biotinylated EB07405 (0.1 μ g/ml) staining of A431 lysate (35 μ g protein in RIPA buffer), exactly mirroring its parental non-biotinylated product. Primary incubation was 1 hour. Detected by chemiluminescence, using streptavidin-HRP and using NAP blocker as a substitute for skimmed milk.
