### Immunogen

Peptide with sequence C-QGLASKWDYEKNE., from the C Terminus of the protein sequence according to NP\_001852.1; NP\_001305726.1.

### Purification and Storage

Purified from goat serum by ammonium sulphate precipitation followed by antigen affinity chromatography using the immunizing peptide.

Supplied at 0.5 mg/ml in Tris saline, 0.02% sodium azide, pH7.3 with 0.5% bovine serum albumin.

Aliquot and store at -20°C. Minimize freezing and thawing.

### Applications Tested

**Peptide ELISA:** antibody detection limit dilution 1:4000.

**Western blot:** Approx 17kDa band observed in Human Skeletal Muscle lysates (calculated MW of 19.6kDa according to NP\_001852.1). See non-biotinylated parental product's datasheet for further QC data. Recommended concentration: 0.1-0.3µg/ml.

### Species Reactivity

**Tested:** Human

**Expected from sequence similarity:** Human



Biotinylated EB07914 (0.1  $\mu\text{g/ml}$ ) staining of Human Skeletal Muscle lysate (35  $\mu\text{g}$  protein in RIPA buffer), exactly mirroring its parental non-biotinylated product. Primary incubation was 1 hour. Detected by chemiluminescence, using streptavidin-HRP and using NAP blocker as a substitute for skimmed milk.
