Immunogen

Peptide with sequence C-KIRQLPIDSDDSRP, from the internal region of the protein sequence according to NP_000822.2.

Purification and Storage

Purified from goat serum by ammonium sulphate precipitation followed by antigen affinity chromatography using the immunizing peptide.

Supplied at 0.5 mg/ml in Tris saline, 0.02% sodium azide, pH7.3 with 0.5% bovine serum albumin.

Aliquot and store at -20°C. Minimize freezing and thawing.

Applications Tested

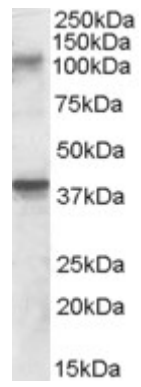
Peptide ELISA: antibody detection limit dilution 1:64000.

Western blot: Approx. 110kDa band observed in Mouse Brain and Rat Brain lysates (calculated MW of 104kDa according to Human NP_000822.2, and to Rat NP_001106187.1). Recommended concentration: 0.3-1µg/ml. An additional band of unknown identity was also consistently observed at 39kDa. This band was successfully blocked by incubation with the immunising peptide. We would appreciate any feedback from people in the field - have any such results been reported with other antibodies/lysates? Have any further splice variants/modified forms been reported?

Species Reactivity

Tested: Rat, Mouse

Expected from sequence similarity: Human, Mouse, Rat, Dog, Cow



EB08683(0.3 μ g/ml) staining of Rat Brain lysate (35 μ g protein in RIPA buffer). Primary incubation was 1 hour.
Detected by chemiluminescence.
