### Immunogen

Peptide with sequence C-EFDKPEKLLSRKD, from the C Terminus of the protein sequence according to NP\_000343.2.

### Purification and Storage

Purified from goat serum by ammonium sulphate precipitation followed by antigen affinity chromatography using the immunizing peptide.

Supplied at 0.5 mg/ml in Tris saline, 0.02% sodium azide, pH7.3 with 0.5% bovine serum albumin.

Aliquot and store at -20°C. Minimize freezing and thawing.

### Applications Tested

**Peptide ELISA:** antibody detection limit dilution 1:8000.

**Western blot:** Approx 170kDa band observed in Human Brain (Cerebellum) lysates (calculated MW of 177kDa according to NP\_000343.2). Recommended concentration: 0.5-1.5µg/ml. An additional band of unknown identity was also consistently observed at 23kDa. This band was successfully blocked by incubation with the immunising peptide. We would appreciate any feedback from people in the field - have any such results been reported with other antibodies/lysates? Have any further splice variants/modified forms been reported?

### Species Reactivity

**Tested:** Human

**Expected from sequence similarity:** Human; Mouse, Rat, Dog



EB08736 (0.5 $\mu$ g/ml) staining of Human Cerebellum lysate (35 $\mu$ g protein in RIPA buffer). Primary incubation was 1 hour. Detected by chemiluminescence.
