### Immunogen

Peptide with sequence C-GEYLFERLTLKHD., from the C Terminus of the protein sequence according to NP\_000137.2.

### Purification and Storage

Purified from goat serum by ammonium sulphate precipitation followed by antigen affinity chromatography using the immunizing peptide.

Supplied at 0.5 mg/ml in Tris saline, 0.02% sodium azide, pH7.3 with 0.5% bovine serum albumin.

Aliquot and store at -20°C. Minimize freezing and thawing.

### Applications Tested

**Peptide ELISA:** antibody detection limit dilution 1:128000.

**Western blot:** Approx 20kDa band observed in Rat Brain lysates (calculated MW of 20.7kDa according to Rat NP\_071945.3). See non-biotinylated parental product's datasheet for further QC data. Recommended concentration: 1-3µg/ml.

### Species Reactivity

**Tested:** Human, Mouse, Rat

**Expected from sequence similarity:** Human, Mouse, Rat, Dog, Cow



Biotinylated EB09092 (1 $\mu$ g/ml) staining of Rat Brain lysate (35 $\mu$ g protein in RIPA buffer), exactly mirroring its parental non-biotinylated product. Primary incubation was 1 hour. Detected by chemiluminescence, using streptavidin-HRP and using NAP blocker as a substitute for skimmed milk.
