Immunogen

Peptide with sequence C-GSLLPIHPVTSG, from the C Terminus of the protein sequence according to NP_821068.1; NP_066954.2; NP_821070.1.

Purification and Storage

Purified from goat serum by ammonium sulphate precipitation followed by antigen affinity chromatography using the immunizing peptide.

Supplied at 0.5 mg/ml in Tris saline, 0.02% sodium azide, pH7.3 with 0.5% bovine serum albumin.

Aliquot and store at -20°C. Minimize freezing and thawing.

Applications Tested

Peptide ELISA: antibody detection limit dilution 1:32000.

Western blot: Approx 37kDa band observed in Human, Mouse and Rat Liver lysates and in lysates of cell line HepG2 (calculated MW of 36.8kDa according to NP_066954.2).

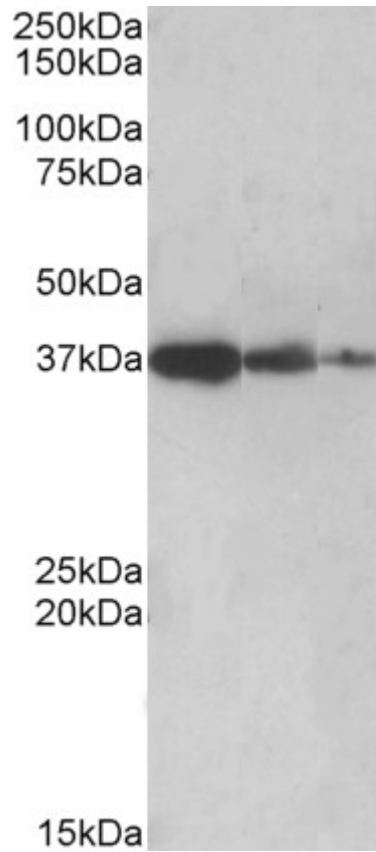
Recommended concentration: 0.5-2µg/ml. Primary incubation was 1 hour.

IHC: Paraffin embedded Human Testis. Recommended concentration: 3.75µg/ml.

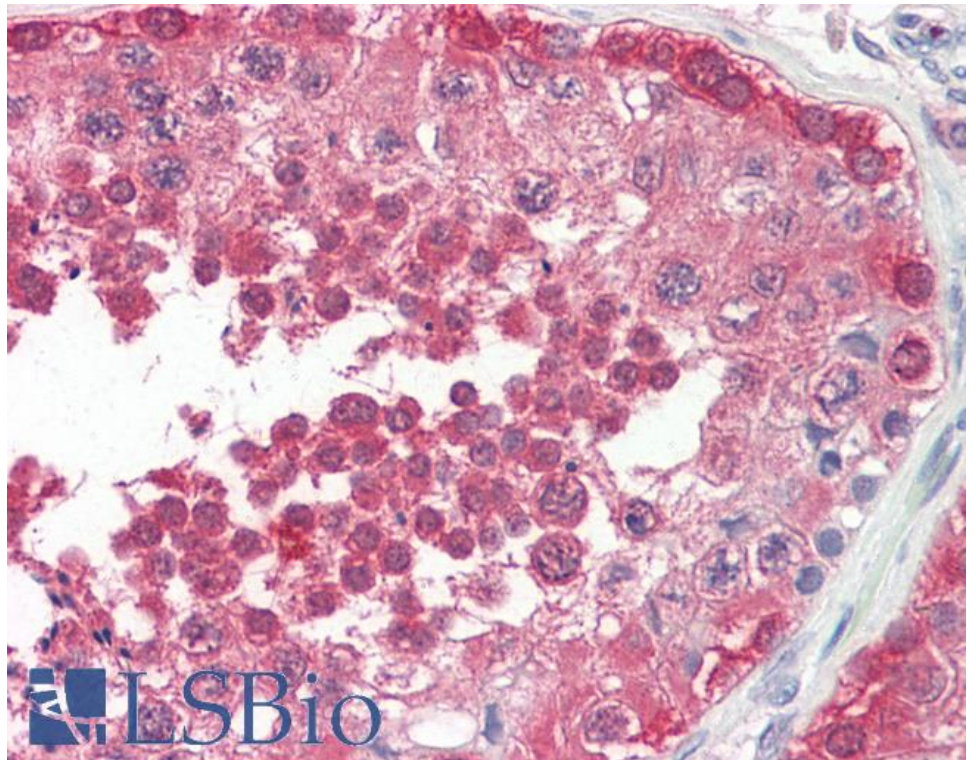
Species Reactivity

Tested: Human, Mouse, Rat

Expected from sequence similarity: Human, Mouse, Rat, Dog, Cow



EB09407 (0.5 μ g/ml) staining of Human Liver lysate (lane 1), Mouse Liver (lane 2) and Rat Liver (lane 3) (35 μ g protein in RIPA buffer). Detected by chemiluminescence.



EB09407 (3.75 μ g/ml) staining of paraffin embedded Human Testis. Steamed antigen retrieval with citrate buffer pH 6, AP-staining.
