### Immunogen

Peptide with sequence C-RLIRSEPTYNQPVQQ, from the internal region of the protein sequence according to NP\_997244.3.

### Purification and Storage

Purified from goat serum by ammonium sulphate precipitation followed by antigen affinity chromatography using the immunizing peptide.

Supplied at 0.5 mg/ml in Tris saline, 0.02% sodium azide, pH7.3 with 0.5% bovine serum albumin.

Aliquot and store at -20°C. Minimize freezing and thawing.

### Applications Tested

**Peptide ELISA:** antibody detection limit dilution 1:8000.

**Western blot:** Not yet tested - our routinely used western blotting protocol does not allow detection of proteins as large as the calculated size of 351kDa according to NP\_997244.3. Therefore we cannot recommend an optimal concentration and the antibody is an aspiring product. We would appreciate any feedback from people in the field - have any results been reported with other antibodies/lysates? Have any further splice variants/modified forms been reported?
