### Immunogen

Peptide with sequence C-QPATYQTSGN, from the internal region of the protein sequence according to NP\_005513.1; NP\_705873.2.

### Purification and Storage

Purified from goat serum by ammonium sulphate precipitation followed by antigen affinity chromatography using the immunizing peptide.

Supplied at 0.5 mg/ml in Tris saline, 0.02% sodium azide, pH7.3 with 0.5% bovine serum albumin.

Aliquot and store at -20°C. Minimize freezing and thawing.

### Applications Tested

**Peptide ELISA:** antibody detection limit dilution 1:8000.

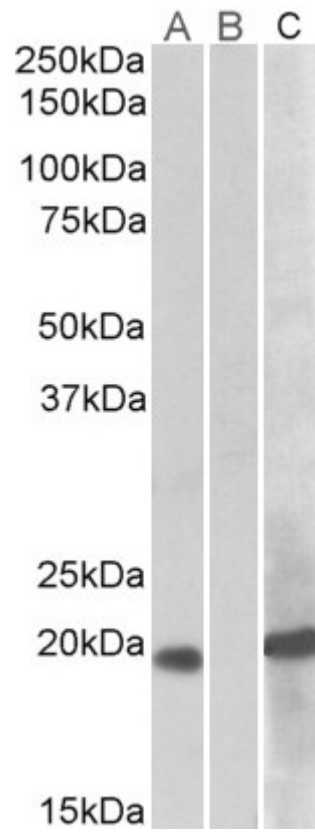
**Western blot:** In transfected HEK293 transiently expressing Human HOXA1 (MYC and DYKDDDDK tagged), a band of approx. 19kDa is observed. No bands are observed in mock-transfected HEK293 and the same band is observed using anti-MYC Tag antibody. Recommended concentration, 1-3µg/ml.

### Species Reactivity

**Tested:** Human

HEK293 lysate (10ug protein in RIPA buffer) overexpressing Human HOXA1 (RC222721) with C-terminal MYC tag probed with EB09847 (1ug/ml) in Lane A and probed with anti-MYC Tag (1/1000) in lane C. Mock-transfected HEK293 probed with EB09847 (1mg/ml) in Lane B. Primary incubations were for 1 hour. Detected by chemiluminescence.
