Immunogen

Peptide with sequence SLLGDLGHTPLS-C, from the N Terminus of the protein sequence according to NP_038462.1.

Purification and Storage

Purified from goat serum by ammonium sulphate precipitation followed by antigen affinity chromatography using the immunizing peptide.

Supplied at 0.5 mg/ml in Tris saline, 0.02% sodium azide, pH7.3 with 0.5% bovine serum albumin.

Aliquot and store at -20°C. Minimize freezing and thawing.

Applications Tested

Peptide ELISA: antibody detection limit dilution 1:1000.

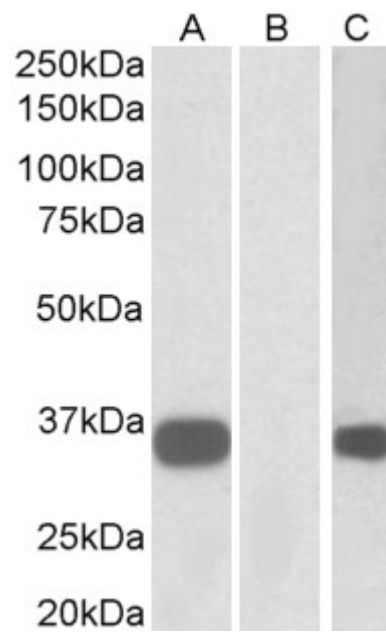
Western blot: In transfected HEK293 transiently expressing Human KCNIP3 a band of approx. 30kDa was observed. No bands are observed in the non-transfected HEK293. The calculated molecular size is 29.2kDa according to NP_038462.1. Recommended concentration, 1-3µg/ml.

Species Reactivity

Tested: Human

Expected from sequence similarity: Human, Dog, Cow



HEK293 lysate (10ug protein in RIPA buffer) overexpressing Human KCNIP3 with C-terminal MYC tag probed with EB10526 (1ug/ml) in Lane A and probed with anti-MYC Tag (1/1000) in lane C. Mock-transfected HEK293 probed with EB10526 (1mg/ml) in Lane B. Primary incubations were for 1 hour. Detected by chemiluminescence.
