Immunogen

Peptide with sequence C-SARDWIFQLKTQAHQ, from the internal region of the protein sequence according to NP_734465.2.

Purification and Storage

Purified from goat serum by ammonium sulphate precipitation followed by antigen affinity chromatography using the immunizing peptide.

Supplied at 0.5 mg/ml in Tris saline, 0.02% sodium azide, pH7.3 with 0.5% bovine serum albumin.

Aliquot and store at -20°C. Minimize freezing and thawing.

Applications Tested

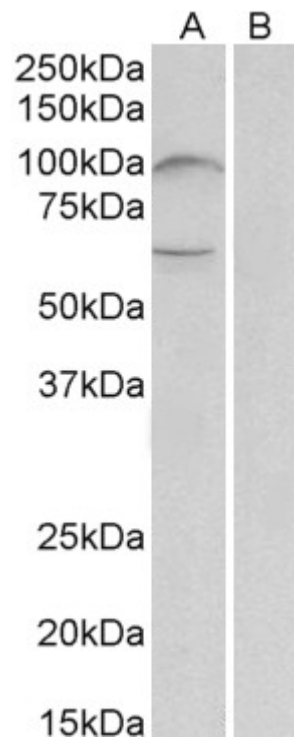
Peptide ELISA: antibody detection limit dilution 1:64000.

Western blot: Approx 90kDa band observed in Human Bone Marrow lysates (calculated MW of 104kDa according to NP_734465.2). Some minor background is detected and is blocked by the immunizing peptide. We call for caution when used for other assays than Western blot. Recommended concentration: 1-3µg/ml.

Species Reactivity

Tested: Human

Expected from sequence similarity: Human, Mouse, Rat, Dog, Pig, Cow



EB11097 (2 μ g/ml) staining of Human Bone Marrow lysate (35 μ g protein in RIPA buffer) with (B) and without (A) blocking with the immunizing peptide. Primary incubation was 1 hour. Detected by chemiluminescence.
