### Immunogen

Peptide with sequence C-KISSYTSYPMHD, from the internal region of the protein sequence according to NP\_079409.3; NP\_001177203.1; XP\_005264629.1; XP\_005264630.1; XP\_005264631.1; XP\_005264632.1.

### Purification and Storage

Purified from goat serum by ammonium sulphate precipitation followed by antigen affinity chromatography using the immunizing peptide.

Supplied at 0.5 mg/ml in Tris saline, 0.02% sodium azide, pH7.3 with 0.5% bovine serum albumin.

Aliquot and store at -20°C. Minimize freezing and thawing.

### Applications Tested

**Peptide ELISA:** antibody detection limit dilution 1:16000.

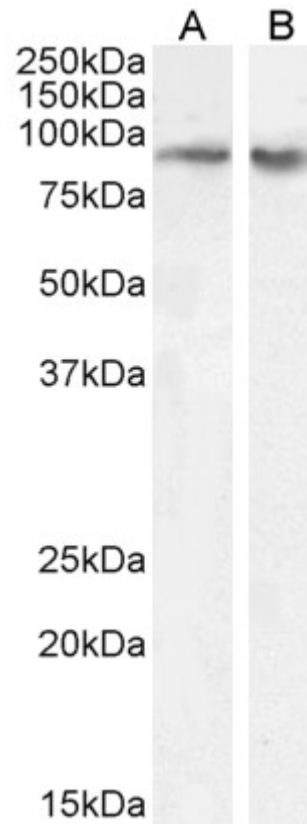
**Western blot:** Approx 90kDa band observed in nuclear lysates of cell line HeLa and lysates of cell line A431 (calculated MW of 94.1kDa according to NP\_079409.3).

Recommended concentration: 0.1-0.3µg/ml. Primary incubation 1 hour at room temperature.

### Species Reactivity

**Tested:** Human

**Expected from sequence similarity:** Human, Mouse, Rat, Pig, Cow
