Source

Chickens were immunized with recombinant Botulinum Neurotoxin Type E Light Chain (Clostridium botulinum). After multiple immunizations in Freund's adjuvant, eggs were collected and the IgY purified. Anti-Botulinum Neurotoxin Type E Light Chain was immunoaffinity purified using the immunogen immobilized on a solid support and conjugated to horseradish peroxidase.

Formulation: Phosphate buffered saline, pH 7.2, 50% glycerol with 0.01% Thimerosal

Purification Method: Egg-yolk derived IgY Affinity Purified
