### Source

Chickens were immunized with highly purified Binary Toxin, B subunit, purified from Clostridium difficile. After multiple immunizations in Freund's adjuvant, eggs were collected and the IgY purified. Anti-Clostridium difficile Binary Toxin, Subunit B was immunoaffinity purified using the immunogen immobilized on a solid support.

### Product

*Product Form:* Affinity purified

*Formulation:* Phosphate buffered saline, pH 7.2 with 0.075% sodium azide

*Purification Method:* Egg-yolk derived IgY Affinity Purified

*Concentration:* See vial for concentration.

### Applications

This antibody has been tested in ELISA -- the midpoint of the dose response curve is 110 ng/ml using a coating of 1 ug of Binary B toxin. This antibody can be used as a capture antibody (1 ug/well) with ACdBTSB-B or ACdBTSB-HRP in an ELISA format. Optimal working dilutions should be determined for your particular assay conditions.

### Storage

Product should be stored at -20°C. Aliquot to avoid freeze/thaw cycles.

*Shipping Conditions:* Ship at ambient temperature.
