Chickens were immunized with highly purified IgG from normal human serum. After multiple immunizations, eggs were collected and the IgY fraction prepared. The anti-human IgG (Fab)2-specific fraction was immunoaffinity-purified from a human IgG (Fab)2 solid phase.
