Chickens were immunized with highly purified human thyroglobulin. After multiple immunizations in Freund's adjuvant, eggs were collected and the IgY fraction prepared. The antibodies were immunoaffinity purified from a human thyroglobulin immunoabsorbant and conjugated to biotin.

Formulation: Phosphate buffered saline, pH 7.2, 50% glycerol with 0.01% Thimerosal
