### Source

Chickens were immunized with highly purified normal mouse IgG. After multiple immunizations, eggs were collected and the IgY fraction prepared.

### Product

*Product Form:* IgY fraction

*Formulation:* Phosphate buffered saline, pH 7.2 with 0.075% sodium azide

*Purification Method:* Egg yolk-derived purified IgY (non affinity purified)

*Concentration:* See vial for concentration.

### Applications

These antibodies contain approximately 10% specific antibodies as tested by ELISA, yield a single precipitin arc when tested against normal mouse serum and in cross-reactivity studies using Ouchterlony, cross-react with human IgG, rat IgG and swine IgG but not appreciably with rabbit, goat, guinea pig, cow, ovine, or horse IgG.

### Storage

Product should be stored at -20°C. Aliquot to avoid freeze/thaw cycles.
