### Source

Chickens were immunized with purified recombinant protein G lacking the albumin binding region. After multiple immunizations in Freund's adjuvant, eggs were collected and the IgY fraction purified. Antibodies were immunoaffinity-purified from a protein G agarose column and conjugated to biotin.

*Product Form:* Biotin conjugated

*Formulation:* Phosphate buffered saline, pH 7.2, 50% glycerol with 0.005% Thimerosal

*Purification Method:* Egg-yolk derived IgY Affinity Purified

*Concentration:* See vial for concentration.
