BIOLOGICAL ACTIVITY			
Description	Hoechst 34580 is a marker dye in Hoechst series. Hoechst is A live nuclear marker dye. Hoechst binds to the grooves in the DNA double strand, which tends to be A/ T-rich DNA strand. Although it binds to all nucleic acids, the A/ T-rich double strand DNA significantly enhances fluorescence intensity Therefore,Hoechst dye can be used for living cell labeling. The fluorescence intensity of Hoechst dye increases with the increase of pH of solution ^[1] .

In Vitro	General Protocol Preparation of Hoechst working solution 1.1 Preparation of the stock solution Dissolve 10 mg of in 5 mL DMSO Note: It is recommended to store the stock solution at 4⊠ or -20⊠ away from light and avoid repetitive freeze-thaw cycles. 1.2 Preparation of Hoechst working solution Dilute the stock solution in serum-free cell culture medium or PBS to obtain final concentration 10 µg/mL Hoechst working solution. Note: Please adjust the concentration of Hoechst working solution according to the actual situation.		



a. Centrifuge at 1000 g at 41 for 3-5 minutes and then discard the supernatant. Wash twice with PBS, 5 minutes each time. The cell density is 1×10⁶/mL.

- b. Add 1 mL of working solution, and then incubate at room temperature for 3-10 minutes.
- c. Centrifuge at 400 g at 4 \boxtimes for 3-4 minutes and then discard the supernatant.
- d. Wash twice with PBS, 5 minutes each time.

2.1 Suspension cells¹/₈6-well plate¹/₈

- e. Resuspend cells with serum-free cell culture medium or PBS. Observation by fluorescence microscopy or flow cytometry.
- 2.2 Adherent cells

1.Cell staining

- a. Culture adherent cells on sterile coverslips.
- b. Remove the coverslip from the medium and aspirate excess medium.
- c. Add 100 µL of working solution, gently shake it to completely cover the cells,and then incubate at room temperature for 3-10 minutes.
- d. Wash twice with medium, 5 minutes each time.Observation by fluorescence microscopy or flow cytometry.
