#### **Background**

The reagents were evaluated for potency, purity and specificity using most or all of the following techniques: immunoelectrophoresis, cross-immunoelectrophoresis, single radial immunodiffusion (Ouchterlony), block titration, ELISA, immunoblotting and enzyme inhibition. This product is intended for use in precipitating and non-precipitating antibody-binding assays (such as e.g., ELISA and Western blotting and immunofluorescence or histochemical techniques); to prepare an

insoluble immuno-affinity adsorbent; for labelling with a marker of the customer's own choice.

## Source

Fructose-6-phosphate kinase is isolated and purified from rabbit muscle. Freund's complete adjuvant is used in the first step of the immunization procedure.

#### **Product**

Purified hyperimmune sheep IgG lyophilised from a solution in phosphate buffered saline (PBS, pH 7.2). No preservative added, as it may interfere with the antibody activity. No foreign protein added.

### **Applications**

Indirect immunofluorescence, ELISA, Dot blot, Immunoblotting.

### **Cross Reactivity**

Cross-reactivities against enzymes of other sources may occur but have not been determined.

#### Specificity

IgG fraction of polyclonal Sheep antiSerum to fructose-6-phosphate kinase from Rabbit muscle.

#### Storage

The lyophilised IgG fraction is shipped at ambient temperature and may be stored at +4°C; prolonged storage at or below -20°C. It is reconstituted by adding 1.0 ml sterile distilled water, spun down to remove insoluble particles, divided into small aliquots, frozen and stored at or below -20°C. Prior to use, an aliquot is thawed slowly at ambient temperature, spun down again and used to prepare working dilutions by adding sterile phosphate buffered saline (PBS, pH 7.2). Repeated thawing and freezing should be avoided. Working dilutions should be stored at +4°C, not refrozen, and preferably used the same day. If a slight precipitation occurs upon storage, this should be removed by centrifugation. It will not affect the performance of the product. Lyophilized at +4°C--at least 10 years. Reconstituted at or below -20°C--3-5 years. Reconstituted at +4°C--7 days.
