Product Details

Background: Secreted as part of the adaptive immune response by plasma B cells, immunoglobulin G

constitutes 75% of serum immunoglobulins. Immunoglobulin G binds to viruses, bacteria, as well as fungi and facilitates their destruction or neutralization via agglutination (and thereby immobilizing them), activation of the compliment cascade, and opsonization for phagocytosis. This product possesses the F(ab')2 fragment, recognized by the two F(ab) fragments yielded

from the digestion of the antibody below the disulfide bond hinge region.

Target Details

Purity/Specificity: This product was prepared from normal serum by a multi-step process which includes

delipidation, salt fractionation and ion exchange chromatography followed by pepsin digestion and extensive dialysis against the buffer stated above. Assay by immunoelectrophoresis resulted in a single precipitin arc against anti-Bovine IgG, anti-Bovine IgG F(ab')2 and anti-Bovine

Serum. No reaction was observed against anti-Bovine IgG F(c) or anti-Pepsin.

Application Note:	Bovine IgG F(ab')2 has been tested in SDS-Page and can be utilized as a control or standard reagent in Western Blotting and ELISA experiments.
Assay Dilutions:	All assays should be optimized by the user. Recommended dilutions (if any) may be listed below.

Storage Condition:	Store vial at 4° C prior to opening. This product is stable 4° C as an undiluted liquid. Dilute only prior to immediate use. For extended storage mix with an equal volume of glycerol, aliquot contents and freeze at -20° C or below. Avoid cycles of freezing and thawing.
Expiration:	Expiration date is one (1) year from date of receipt.
