### Product Details

<b>Background:</b>	Secreted as part of the adaptive immune response by plasma B cells, immunoglobulin G constitutes 75% of serum immunoglobulins. Immunoglobulin G binds to viruses, bacteria, as well as fungi and facilitates their destruction or neutralization via agglutination (and thereby immobilizing them), activation of the compliment cascade, and opsonization for phagocytosis. The whole IgG molecule possesses both the F(c) region, recognized by high-affinity Fc receptor proteins, as well as the F(ab) region possessing the epitope-recognition site. Both heavy and light chains of the antibody molecule are present.

<b>Purity/Specificity:</b>	This product was prepared from normal serum by delipidation, salt fractionation, ion exchange chromatography followed by extensive dialysis against the buffer stated above. Assay by immunoelectrophoresis resulted in a single precipitin arc against anti-Golden Syrian Hamster IgG and anti-Golden Syrian Hamster Serum.

### Application Details

**Application Note:** HAMSTER IgG whole molecule Rhodamine conjugated is designed for immunofluorescence microscopy, fluorescence based plate assays (FLISA) and fluorescent western blotting. This product is also suitable for multiplex analysis, including multicolor imaging, utilizing various commercial platforms.

**Assay Dilutions:** All assays should be optimized by the user. Recommended dilutions (if any) may be listed below.

## Formulation

**Physical State:** Lyophilized

**Concentration:** 1.0 mg/mL by UV absorbance at 280 nm

**Buffer:** 0.02 M Potassium Phosphate, 0.15 M Sodium Chloride, pH 7.2

**Preservative:** 0.01% (w/v) Sodium Azide

**Stabilizer:** 10 mg/mL Bovine Serum Albumin (BSA) - Immunoglobulin and Protease free

**Reconstitution Volume:** 1.0 mL

**Reconstitution Buffer:** Restore with deionized water (or equivalent)

## Shipping & Handling

**Shipping Condition:** Ambient

**Storage Condition:** Store vial at 4° C prior to restoration. For extended storage aliquot contents and freeze at -20° C or below. Avoid cycles of freezing and thawing. Centrifuge product if not completely clear after standing at room temperature. This product is stable for several weeks at 4° C as an undiluted liquid. Dilute only prior to immediate use.

**Expiration:** Expiration date is one (1) year from date of receipt.
