Background:	EPHA8 is a member of the ephrin receptor subfamily of the protein-tyrosine kinase family in which EPH and EPH-related receptors have been implicated in mediating developmental events, particularly in the nervous system. Receptors in the EPH subfamily typically have a single kinase domain and an extracellular region containing a Cys-rich domain and 2 fibronectin type III repeats (1). EPHA8 receptors play a role in axonal pathfinding during development of the mammalian nervous system (2). EPHA8 Protein is ideal for investigators involved in Signaling Proteins, Cellular Proteins, Angiogenesis, Cancer, Cardiovascular Disease, Neurobiology, and Receptor Tyrosine Kinases research.
