NGF- $\beta$ acts through its receptor $\beta$ -NGFR, and is involved in the development and maintenance of the sensory and sympathetic nervous systems. NGF- $\beta$ is also involved in the growth, differentiation and survival of B lymphocytes. Human, mouse and rat proteins show cross-reactivity. Recombinant human NGF- $\beta$ is a non-covalently linked homodimer, containing two 121 amino acid chains, with a total molecular weight of 27.2 kDa. |
