#### **Product Details**

| Background:        | Platelet-Derived Growth Factor (PDGF) is a mitogenic peptide growth hormone carried in the alpha-granules of platelets and is released when platelets adhere to traumatized tissues. Connective tissue cells near the traumatized region respond by initiating the process of replication. The synthesis of PDGF can be induced by IL-1, IL-6, TNF- $\alpha$ , TGF- $\beta$ and EGF. Recombinant human PDGF-AB is a non-glycosylated, disulfide-linked heterodimer, containing one 14.3 kDa alpha-chain and one 12.1 kDa beta-chain, with total molecular weight of 26.4 kDa. |





#### **SDS-PAGE**

SDS-PAGE of Human Platelet Derived Growth Factor-AB Recombinant Protein. Lane 1: 1  $\mu$ g Human PDGF-AB in non-reducing conditions (-). Lane 2: Molecular weight marker. Lane 3: 1  $\mu$ g Human PDGF-AB in reducing conditions (+). Lane 4: Molecular weight marker. Human PDGF-AB is predicted to be a disulfide linked heterodimer with a predicted MW of 25.5 kDa.

#### SDS-PAGE

Bioactivity of Human Platelet Derived Growth Factor-AB Recombinant Protein. Serial dilutions of Human PDGF-AB, starting at 100 ng/mL, were added to 3T3 cells. Cell proliferation was measured after 46 hours and the linear portion of the curve was us used to calculate the ED50. The ED50 of Human PDGF-AB is 1.4-2.1 ng/mL. This value is comparable with the typical expected range of < 1 ng/mL.
