Levels of unprocessed procalcitonin have been shown to rise significantly after bacterial infection, trauma or shock. Recombinant human Procalcitonin is a non-glycosylated protein, containing 116 amino acids, with a molecular weight

of 12.8 kDa.

We recommend adding a carrier protein such as HSA or BSA to 0.1% (i.e. 1.0 mg/mL). For best results aliquot contents and freeze at -20° C or colder. Avoid cycles of freezing and thawing. Centrifuge vial before each opening to dislodge contents from the cap and to clarify if contents are not clear after standing at room temperature.
Expiration:	Expiration date is six (6) months from date of receipt.


