Distinct heavy chains differ in size and composition; alpha and gamma<br>contain approximately 450 amino acids, while $\mu$ and $\varepsilon$ have approximately 550 amino acids. |

# **Target Details**

Purity/Specificity:HUMAN IgM (myeloma) Fab μ fragment was prepared from serum by a multi-step process<br/>which includes delipidation, selective precipitation, tandem molecular sieve chromatography<br/>and trypsin digestion followed by extensive dialysis against the buffer stated above. Assay by<br/>immunoelectrophoresis resulted in a single precipitin arc against anti-Human Serum. No<br/>reaction was observed against anti-Human IgG F(c). Some light chain cross reactivity will occur<br/>with anti-Human IgG.
