Background:	Human IgM (myeloma) Fc5 $\mu$ fragment Biotin conjugate consists of only the $\mu$ (mu) chain of the Fc fragment. Immunoglobulin M is the largest antibody isotype and the first to be secreted against an initial exposure to antigen. IgM is predominantly produced in the spleen. IgM is formed from covalently linking 5 immunoglobulins together. Due to this large size, IgM is typically isolated to the serum.

Purity/Specificity:This product was prepared from normal serum by a multi-step process which includes<br/>delipidation, selective precipitation, ion exchange chromatography followed by tandem<br/>molecular sieve chromatography and extensive dialysis against the buffer stated above. Assay<br/>by immunoelectrophoresis resulted in a single precipitin arc against anti-biotin, anti- Human<br/>IgM, and anti-Human Serum. No reaction was observed against anti-Human IgG F(c) or anti-<br/>Papain.

Shipping Condition:	Ambient
Storage Condition:	Store vial at 4° C prior to restoration. For extended storage aliquot contents and freeze at -20° C or below. Avoid cycles of freezing and thawing. Centrifuge product if not completely clear after standing at room temperature. This product is stable for several weeks at 4° C as an undiluted liquid. Dilute only prior to immediate use.
Expiration:	Expiration date is one (1) year from date of receipt.
