Background:	Interleukin 6 (IL-6) is an important pro-inflammatory and anti-inflammatory cytokine expressed by T cells, macrophages and muscle cells. IL-6 signals through a receptor complex containing two receptors, IL-6R α and gp130. IL-6 has an important function in promoting fever and can serve to stimulate an immune response to trauma. IL-6 is often used for growth of hybridoma cell lines. Human IL-6 is active on mouse and rat cells. Recombinant rat IL-6 is a non-glycosylated protein, containing 188 amino acids, with a molecular weight of 21.8 kDa.

Application Note:	Interleukin-6 Recombinant Protein has been tested by biological activity and is suitable as a control for polyclonal or monoclonal anti-Interleukin-6 in immunological assays.
Assay Dilutions:	All assays should be optimized by the user. Recommended dilutions (if any) may be listed below.
Other:	Endotoxin Level: Measured by kinetic LAL analysis and is typically ≤ 1 EU/µg protein. Biologic Activity: The activity is determined by a dose-dependent stimulation of mouse 7TD1 cells and is typically less than 0.01 ng/mL.

Storage Condition:	Store vial at 4° C prior to restoration. Dilute only prior to immediate use. Maintain sterility. This product DOES NOT contain preservative. DO NOT VORTEX. We recommend adding a carrier protein such as HSA or BSA to 0.1% (i.e. 1.0 mg/mL). For best results aliquot contents and freeze at -20° C or colder. Avoid cycles of freezing and thawing. Centrifuge vial before each opening to dislodge contents from the cap and to clarify if contents are not clear after standing at room temperature.
Expiration:	Expiration date is six (6) months from date of receipt.



Rat IL-6 Bioactivity Data



SDS-PAGE

Bioactivity of Rat Interleukin-6 Recombinant Protein. 7TD1 cells were cultured with 0 to 250 pg/mL Rat IL-6. Cell proliferation was measured after 66 hours and the linear portion of the curve was us used to calculate the ED50. The ED50 of Rat IL-6 is 5.9-8.9 pg/mL. This value is comparable to expected range of less than 20 pg/mL.
