



#### POTENTIAL HEALTH EFFECTS

#### ACUTE HEALTH EFFECTS

#### SWALLOWED

■ The material has NOT been classified by EC Directives or other classification systems as "harmful by ingestion".

This is because of the lack of corroborating animal or human evidence.

#### EYE

Although the material is not thought to be an irritant (as classified by EC Directives), direct contact with the eye may cause transient discomfort characterised by tearing or conjunctival redness (as with windburn).
Slight abrasive damage may also result.

#### SKIN

■ The material is not thought to produce adverse health effects or skin irritation following contact (as classified by EC Directives using animal models).

Nevertheless, good hygiene practice requires that exposure be kept to a minimum and that suitable gloves be used in an occupational setting.

Open cuts, abraded or irritated skin should not be exposed to this material.

■ Entry into the blood-stream, through, for example, cuts, abrasions or lesions, may produce systemic injury with harmful effects.

Examine the skin prior to the use of the material and ensure that any external damage is suitably protected.

#### INHALED

■ The material is not thought to produce adverse health effects or irritation of the respiratory tract (as classified by EC Directives using animal models).

Nevertheless, good hygiene practice requires that exposure be kept to a minimum and that suitable control measures be used in an occupational setting.

■ Persons with impaired respiratory function, airway diseases and conditions such as emphysema or chronic bronchitis, may incur further disability if excessive concentrations of particulate are inhaled.

If prior damage to the circulatory or nervous systems has occurred or if kidney damage has been sustained, proper screenings should be conducted on individuals who may be exposed to further risk if handling and use of the material result in excessive exposures.

#### CHRONIC HEALTH EFFECTS

■ There is limited evidence that, skin contact with this product is more likely to cause a sensitisation reaction in some persons compared to the general population.

Long term exposure to high dust concentrations may cause changes in lung function i.e. pneumoconiosis; caused by particles less than 0.5 micron penetrating and remaining in the lung. Prime symptom is breathlessness; lung shadows show on X-ray.

Biotin is a water soluble B-group vitamin, also known as Vitamin H, which is rapidly metabolised and excreted in the urine.

Animal testing revealed inconclusive results as to whether it affected foetal growth or caused skin reactions.

#### Section 4 - FIRST AID MEASURES

#### SWALLOWED

Immediately give a glass of water.

• First aid is not generally required. If in doubt, contact a Poisons Information Centre or a doctor.

If this product comes in contact with eyes

- Wash out immediately with water.
- If irritation continues, seek medical attention.
- Removal of contact lenses after an eye injury should only be undertaken by skilled personnel.

#### SKIN

#### EXTINGUISHING MEDIA

- Water spray or fog.
- Foam.
- Dry chemical powder.
- BCF (where regulations permit).

#### **FIRE FIGHTING**

- Alert Fire Brigade and tell them location and nature of hazard.
- Wear breathing apparatus plus protective gloves.
- Prevent, by any means available, spillage from entering drains or water courses.
- Use water delivered as a fine spray to control fire and cool adjacent area.

#### GENERAL FIRE HAZARDS/HAZARDOUS COMBUSTIBLE PRODUCTS

- Combustible solid which burns but propagates flame with difficulty; it is estimated that most organic dusts are combustible (circa 70%) - according to the circumstances under which the combustion process occurs, such materials may cause fires and / or dust explosions.
- Avoid generating dust, particularly clouds of dust in a confined or unventilated space as dusts may form an
  explosive mixture with air, and any source of ignition, i.e. flame or spark, will cause fire or explosion. Dust
  clouds generated by the fine grinding of the solid are a particular hazard; accumulations of fine dust (420
  micron or less) may burn rapidly and fiercely if ignited particles exceeding this limit will generally not form
  flammable dust clouds.; once initiated, however, larger particles up to 1400 microns diameter will contribute to
  the propagation of an explosion.
- In the same way as gases and vapours, dusts in the form of a cloud are only ignitable over a range of concentrations; in principle, the concepts of lower explosive limit (LEL) and upper explosive limit (UEL).are applicable to dust clouds but only the LEL is of practical use; - this is because of the inherent difficulty of achieving homogeneous dust clouds at high temperatures (for dusts the LEL is often called the "Minimum Explosible Concentration", MEC)
- A dust explosion may release of large quantities of gaseous products; this in turn creates a subsequent pressure rise of explosive force capable of damaging plant and buildings and injuring people.

Combustion products include carbon monoxide (CO), carbon dioxide (CO2), nitrogen oxides (NOx), sulfur oxides (SOx), other pyrolysis products typical of burning organic material.

May emit corrosive fumes.

#### FIRE INCOMPATIBILITY

 Avoid contamination with oxidising agents i.e. nitrates, oxidising acids, chlorine bleaches, pool chlorine etc. as ignition may result

#### Section 6 - ACCIDENTAL RELEASE MEASURES

#### **MINOR SPILLS**

- Clean up all spills immediately.
- Avoid breathing dust and contact with skin and eyes.
- Wear protective clothing, gloves, safety glasses and dust respirator.
- Use dry clean up procedures and avoid generating dust.

#### MAJOR SPILLS

Moderate hazard.

- CAUTION Advise personnel in area.
- Alert Emergency Services and tell them location and nature of hazard.
- Control personal contact by wearing protective clothing.
- Prevent, by any means available, spillage from entering drains or water courses.

#### Section 7 - HANDLING AND STORAGE

#### **PROCEDURE FOR HANDLING**

- Avoid all personal contact, including inhalation.
- Wear protective clothing when risk of exposure occurs.
- Use in a well-ventilated area.
- Prevent concentration in hollows and sumps.

Empty containers may contain residual dust which has the potential to accumulate following settling. Such dusts may explode in the presence of an appropriate ignition source.

- Do NOT cut, drill, grind or weld such containers.
- In addition ensure such activity is not performed near full, partially empty or empty containers without appropriate workplace safety authorisation or permit.

#### **RECOMMENDED STORAGE METHODS**

- Lined metal can, lined metal pail/ can.
- Plastic pail.
- Polyliner drum.
- Packing as recommended by manufacturer.

#### STORAGE REQUIREMENTS

#### PERSONAL PROTECTION



#### RESPIRATOR

Particulate. (AS/NZS 1716 & 1715, EN 1432000 & 1492001, ANSI Z88 or national equivalent)

- EYE
- Safety glasses with side shields.
- Chemical goggles.
- Contact lenses may pose a special hazard; soft contact lenses may absorb and concentrate irritants. A written policy document, describing the wearing of lens or restrictions on use, should be created for each workplace or task. This should include a review of lens absorption and adsorption for the class of chemicals in use and an account of injury experience. Medical and first-aid personnel should be trained in their removal and suitable equipment should be readily available. In the event of chemical exposure, begin eve irrigation immediately and remove contact lens as soon as practicable. Lens should be removed at the first signs of eve redness or irritation - lens should be removed in a clean environment only after workers have washed hands thoroughly. [CDC NIOSH Current Intelligence Bulletin 59], [AS/NZS 1336 or national equivalent]

#### HANDS/FEET

NOTE

- The material may produce skin sensitisation in predisposed individuals. Care must be taken, when removing gloves and other protective equipment, to avoid all possible skin contact.
- Contaminated leather items, such as shoes, belts and watch-bands should be removed and destroyed.

#### ENGINEERING CONTROLS

Engineering controls are used to remove a hazard or place a barrier between the worker and the hazard. Well-designed engineering controls can be highly effective in protecting workers and will typically be independent of worker interactions to provide this high level of protection.

The basic types of engineering controls are

Process controls which involve changing the way a job activity or process is done to reduce the risk. Enclosure and/or isolation of emission source which keeps a selected hazard "physically" away from the worker and ventilation that strategically "adds" and "removes" air in the work environment.

#### TOXICITY AND IRRITATION

■ unless otherwise specified data extracted from RTECS - Register of Toxic Effects of Chemical Substances.

■ P-aminobenzoic acid (PABA) can be derived from some consumable food, and is used in the treatment of the hair, skin, collagen and vascular disorders. PABA and its derivatives can be applied on the skin as sunscreens and local anaesthetics for temporary pain relief. It is used to darken grey hair and prevent hair loss. They also enhance the effects of cortisone, oestrogen, and other hormones. High doses can cause nausea, vomiting, abdominal cramps, gastrointestinal irritation, itching, rash, fever, blood cell abnormalities, altered memory and liver disease. Derivatives of PABA have been associated with acute allergic reactions. Several drugs may worsen these effects, and cross-reactivity can ouccr between aminobenzoic acid and a number of other drugs known to cause photosensitivity reactions, including thiazides, sulphonamides, sulfonylureas, furosemide and carbonic anhydrase inhibitors, as well as benzocaine and p-phenylenediamine. Individuals who have had photosensitivity reactions to these drugs should not use sunscreen containing aminobenzoic acid or its derivatives. Some ingredients in sunscreens such as nitrosamines and padimate can cause cancer and DNA damage.

Sulfa drugs (a group of early antibacterials) are chemically similar to PABA, and the chemically related 4-aminosalicylic acid has produced allergic reactions in 5% of adult patients treated with the sodium salt. Fever, joint pain, enlarged lymph nodes and more rarely, a syndrome resembling glandular fever may occur. Other apparently allergic reactions to aminosalicylate include jaundice, liver damage, inflammation of the pancreas,

accumulation in the lungs, inflammation of the brain and kidneys, and kidney failure. Skin rashes often occur after treatment, with a scaling skin inflammation.

No significant acute toxicological data identified in literature search.

#### **Disposal Instructions**

All waste must be handled in accordance with local, state and federal regulations.
