Section 8 - Precautions for Safe Handling and Use

Steps to be Taken in Case Material is Released or Spilled wear protective equipment. sweep up, place in a bag and hold for waste disposal. avoid raising dust. ventilate area and wash spill site after material pickup is complete.

Waste Disposal Method dissolve or mix the material with a combustible solvent and burn in a chemical incinerator equipped with an afterburner and scrubber. observe all federal, state and local environmental regulations.

Precautions to Be Taken in Handling and Storage mechanical exhaust required. do not breath dust. avoid contact with eyes, skin and clothing. keep tightly closed. store in a cool dry place.
