4. FIRST AID MEASURES

General Advice

Methods and materials for containment and cleaning up

7. HANDLING AND STORAGE

Precautions for safe handling

Keep container tightly close in a dry and well-ventilated place. Store under inert atmosphere at -20°C.

Respiratory protection
