6. ACCIDENTAL RELEASE MEASURES

Personal Precautions

Material should not be allowed to enter the environment. Prevent further spillage or discharge into drains, if safe to do so.

Methods and Materials for Containment and Clean Up

Contain the spill and then collect using non-combustible absorbent material (such as clay, diatomaceous earth, vermiculite or other appropriate material). Place material in a suitable, sealable container and then dispose according to local/national regulations and guidance (see Section 13).

7. HANDLING AND STORAGE

Precautions for Safe Handling

Avoid contact with skin and eyes. Ventilation and proper handling are to be used to prevent the formation of dusts and mists. Normal measures for preventative fire protection. No smoking, eating or drinking around this material. Wash hands after use.

Conditions for Safe Storage, Including any Incompatibilities

Ensure container is kept securely closed before and after use. Keep in a well ventilated area and do not store with strong oxidizers or other incompatible materials (see Section 10). Hygroscopic/moisture sensitive. Store at / 20° C under inert atmosphere.
