EMERGENCY OVERVIEW

Harmful if swallowed.

POTENTIAL HEALTH EFFECTS

ACUTE HEALTH EFFECTS

SWALLOWED

- Accidental ingestion of the material may be harmful; animal experiments indicate that ingestion of less than 150 gram may be fatal or may produce serious damage to the health of the individual.
- Lithium, in large doses, can cause dizziness and weakness.
- If a low salt diet is in place, kidney damage can result.
- The substance and/or its metabolites may bind to hemoglobin inhibiting normal uptake of oxygen.

This condition, known as "methemoglobinemia", is a form of oxygen starvation (anoxia).

EYE

■ This material can cause eye irritation and damage in some persons.

SKIN

- This material can cause inflammation of the skin oncontact in some persons.
- The material may accentuate any pre-existing dermatitis condition.
- Skin contact with the material may damage the health of the individual; systemic effects may result following absorption.
- Open cuts, abraded or irritated skin should not be exposed to this material.
- Entry into the blood-stream, through, for example, cuts, abrasions or lesions, may produce systemic injury with harmful effects.

Examine the skin prior to the use of the material and ensure that any external damage is suitably protected.

INHALED

- The material can cause respiratory irritation in some persons.
- The body's response to such irritation can cause further lung damage.
- Persons with impaired respiratory function, airway diseases and conditions such as emphysema or chronic bronchitis, may incur further disability if excessive concentrations of particulate are inhaled.

CHRONIC HEALTH EFFECTS

■ Long-term exposure to respiratory irritants may result in disease of the airways involving difficult breathing and related systemic problems. Limited evidence suggests that repeated or long-term occupational exposure may produce cumulative health effects involving organs or biochemical systems.

Lithium compounds can affect the nervous system and muscle. This can cause tremor, inco-ordination, spastic jerks and very brisk reflexes. Long term exposure to high dust concentrations may cause changes in lung function i.e. pneumoconiosis; caused by particles less than 0.5 micron penetrating and remaining in the lung.

Section 4 - FIRST AID MEASURES

SWALLOWED

EYE

■ If this product comes in contact with the eyes: · Wash out immediately with fresh running water. · Ensure complete irrigation of the eye by keeping eyelids apart and away from eye and moving the eyelids by occasionally lifting the upper and lower lids.

SKIN

■ If skin contact occurs: · Immediately remove all contaminated clothing, including footwear · Flush skin and hair with running water (and soap if available).

INHALED

· If fumes or combustion products are inhaled remove from contaminated area. · Lay patient down. Keep warm and rested.

NOTES TO PHYSICIAN

- Clinical effects of lithium intoxication appear to relate to duration of exposure as well as to level.
- Lithium produce a generalized slowing of the electroencephalogram; the anion gap may increase in severe cases.
- · Emesis (or lavage if the patient is obtunded or convulsing) is indicated for ingestions exceeding 40 mg (Li)/Kg.

The toxicity of nitrates and nitrites result from their vasodilating properties and their propensity to form methemoglobin.

- · Most produce a peak effect within 30 minutes.
- · Clinical signs of cyanosis appear before other symptoms because of the dark pigmentation of methemoglobin.



EYE

- · Chemical goggles.
- · Full face shield.

HANDS/FEET

■ Wear chemical protective gloves, eg. PVC.

Suitability and durability of glove type is dependent on usage. Important factors in the selection of gloves include: such as:

- · frequency and duration of contact,
- · chemical resistance of glove material,
- · glove thickness and
- · dexterity

Select gloves tested to a relevant standard (e.g. Europe EN 374, US F739).

- · When prolonged or frequently repeated contact may occur, a glove with a protection class of 5 or higher (breakthrough time greater than 240 minutes according to EN 374) is recommended.
- · When only brief contact is expected, a glove with a protection class of 3 or higher (breakthrough time greater than 60 minutes according to EN 374) is recommended.
- · Contaminated gloves should be replaced.

Gloves must only be worn on clean hands. After using gloves, hands should be washed and dried thoroughly. Application of a non-perfumed moisturiser is recommended.

- · DO NOT wear cotton or cotton-backed gloves.
- · DO NOT wear leather gloves.
- · Promptly hose all spills off leather shoes or boots or ensure that such footwear is protected with PVC over-shoes.

- \cdot Some plastic personal protective equipment (PPE) (e.g. gloves, aprons, overshoes) are not recommended as they may produce static electricity.

Section 10 - CHEMICAL STABILITY

CONDITIONS CONTRIBUTING TO INSTABILITY

· Presence of incompatible materials.

· Product is considered stable under normal handling conditions.

STORAGE INCOMPATIBILITY

- for metal nitrates:
- · Segregate from heavy metals, phosphides, sodium acetate, lead nitrate, tartrates, trichloroethylene,
- · Avoid shock and heat.
- · Mixtures of metal nitrates with alkyl esters may explode due to the formation of unstable alkyl nitrates.
- Mixtures of a nitrate with phosphorous, tin(II) chloride and other reducing agents may react explosively.
- Mixtures containing nitrates and organic materials are potentially dangerous, especially if acidic materials or heavy metals are present.
- · Fibrous organic material, jute, wood and similar cellulosic material can become highly combustible by nitrate impregnation
- Metal nitrates are incompatible with cyanides, thiocyanates, isothiocyanates and hypophosphites. Avoid reaction with the following which can cause an explosion: barium thiocyanate, boron phosphide, cyanides, sodium hypophosphite, sulfur and charcoal, powdered aluminium or aluminium oxide, sodium thiosulfate.
- · Mixtures of metal nitrates and phosphinates may explode on heating
- · A mixture of aluminium powder, water and metal nitrate may explode due to a self accelerating reaction.
- · Mixtures containing nitrates, nitrites and organic materials are potentially dangerous, especially in the presence of acidic materials and heavy metals.
- · Metals and their oxides or salts may react violently with chlorine trifluoride and bromine trifluoride.
- · These trifluorides are hypergolic oxidisers. They ignites on contact (without external source of heat or ignition) with recognised fuels contact with these materials, following an ambient or slightly elevated temperature, is often violent and may produce ignition.
- · The state of subdivision may affect the results.
- · Inorganic reducing agents react with oxidizing agents to generate heat and products that may be flammable, combustible, or otherwise reactive. Their reactions with oxidizing agents may be violent.
- · Incidents involving interaction of active oxidants and reducing agents, either by design or accident, are usually very energetic and examples of so-called redox reactions.
- $\cdot \ \text{Avoid any contamination of this material as it is very reactive and any contamination is potentially hazardous.}$

TOXICITY AND IRRITATION

LITHIUM NITRATE:

- unless otherwise specified data extracted from RTECS Register of Toxic Effects of Chemical Substances.
- Asthma-like symptoms may continue for months or even years after exposure to the material ceases. This may be due to a non-allergenic condition known as reactive airways dysfunction syndrome (RADS) which can occur following exposure to high levels of highly irritating compound. Key criteria for the diagnosis of RADS include the absence of preceding respiratory disease, in a non-atopic individual, with abrupt onset of persistent asthma-like symptoms within minutes to hours of a documented exposure to the irritant. A reversible airflow pattern, on spirometry, with the presence of moderate to severe bronchial hyperreactivity on methacholine challenge testing and the lack of minimal lymphocytic inflammation, without eosinophilia, have also been included in the criteria for diagnosis of RADS. RADS (or asthma) following an irritating inhalation is an infrequent disorder with rates related to the concentration of and duration of exposure to the irritating substance. Industrial bronchitis, on the other hand, is a disorder that occurs as result of exposure due to high concentrations of irritating substance (often particulate in nature) and is completely reversible after exposure ceases. The disorder is characterised by dyspnea, cough and mucus production.

No significant acute toxicological data identified in literature search.
