4. FIRST AID MEASURES

General Advice

6. ACCIDENTAL RELEASE MEASURES

Environmental precautions

Do not let product enter drains.

Personal precautions

Use personal protective equipment. Avoid dust or aerosol formation. Avoid breathing vapours, mist or gas. Ensure adequate ventilation.

Methods and materials for containment and cleaning up

Contain spillage, and then collect with non-combustible absorbent material, (e.g. sand, earth, diatomaceous earth, vermiculite) and place in container for disposal according to local / national regulations (see section 13). Keep in suitable, closed containers for disposal.

7. HANDLING AND STORAGE

Precautions for safe handling

Avoid contact with skin and eyes. Avoid formation of dust or aerosols. Provide appropriate exhaust ventilation at places where dust/aerosol is formed. Normal measures for preventative fire protection.

Conditions for safe storage

Keep container tightly close in a dry and well-ventilated place. Store at -20°C under inert atmosphere.

Respiratory protection

Where risk assessment shows air-purifying respirators are appropriate use a full-face mask with approved organic vapour cartridges as a backup to engineering controls. Hand protection
