### 4. FIRST AID MEASURES

### 6. ACCIDENTAL RELEASE MEASURES

#### Personal Precautions

Use personal protective equipment. Avoid dust or aerosol formation. Avoid breathing vapors, mist or gas. Ensure adequate ventilation.

#### Environmental Precautions

Do not let product enter drains.

#### Methods and Materials for Containment and Clean Up

Contain spillage, and then collect with non-combustible absorbent material, (e.g. sand, earth, diatomaceous earth, vermiculite) and place in container for disposal according to local / national regulations (see section 13). Keep in suitable, closed containers for disposal.

### 7. HANDLING AND STORAGE

#### Precautions for Safe Handling

Avoid contact with skin and eyes. Avoid formation of dust or aerosols. Provide appropriate exhaust ventilation at places where dust/aerosol is formed. Normal measures for preventative fire protection.

#### Conditions for Safe Storage, Including any Incompatibilities

Keep container tightly closed in a dry and well-ventilated place. Store at -20° C.

Use mechanical exhaust or laboratory fume hood to avoid exposure.

#### Personal Protective Equipment

##### Respiratory Protection

Where risk assessment shows air-purifying respirators are appropriate use a full-face particle respirator type N100 (US) or type P3 (EN 143) respirator cartridges as a backup to engineering controls. If the respirator is the sole means of protection, use a full-face supplied air respirator. ##### Eye Protection

Face shield or safety glasses. Use equipment for eye protection tested and approved under appropriate government standards such as NIOSH (US) or EN 166(EU).
