ROUTE OF EXPOSURE

Section 8 - Precautions for Safe Handling and Use

Steps to be Taken in Case Material is Released or Spilled:

wear self-contained breathing apparatus, rubber boots and heavy rubber gloves. sweep up, place in a bag and hold for waster disposal. Avoid raising dust. Ventilate area and wash spill site after material pickup is complete.

Waste Disposal Method:

dissolve or mix material with a combustible solvent and burn in a chemical incinerator equipped with an afterburner and scrubber. Observe all federal, state and local environmental regulations

Precautions to Be Taken in Handling and Storage:

wear appropriate NIOSH/MSHA-approved respirator. Chemical-resistant gloves, safety goggles, other protective clothing. use only in a chemical fume hood. Oxidizes in the presence of air, store under nitrogen. Store at -20° C.
