#### **RISK**

# **POTENTIAL HEALTH EFFECTS**

#### **ACUTE HEALTH EFFECTS**

#### **SWALLOWED**

- Accidental ingestion of the material may be harmful; animal experiments indicate that ingestion of less than 150 gram may be fatal or may produce serious damage to the health of the individual.
- CAUTION: Pyrogen may produce fever DO NOT pipette by mouth.

Pyrogenic activity may cause high fever, sweating and a general feeling of malaise.

#### **EYE**

■ Although the material is not thought to be an irritant, direct contact with the eye may cause transient discomfort characterized by tearing or conjunctival redness (as with windburn).

Slight abrasive damage may also result.

#### SKIN

■ Skin contact is not thought to produce harmful health effects (as classified using animal models).

Systemic harm, however, has been identified following exposure of animals by at least one other route and the material may still produce health damage following entry through wounds, lesions or abrasions.

- Open cuts, abraded or irritated skin should not be exposed to this material.
- Entry into the blood-stream, through, for example, cuts, abrasions or lesions, may produce systemic injury with harmful effects.

#### **INHALED**

#### **CHRONIC HEALTH EFFECTS**

■ Results in experiments suggest that this material may cause disorders in the development of the embryo or fetus, even when no signs of poisoning show in the mother.

There is some evidence that inhaling this product is more likely to cause a sensitization reaction in some persons compared to the general population.

There is limited evidence that, skin contact with this product is more likely to cause a sensitization reaction in some persons compared to the general population.

Long term exposure to high dust concentrations may cause changes in lung function i.e. pneumoconiosis; caused by particles less than 0.5 micron penetrating and remaining in the lung.

Respiratory sensitization may result in allergic/asthma like responses; from coughing and minor breathing difficulties to bronchitis with wheezing, gasping.

#### **SWALLOWED**

------BASIC TREATMENT

- · Establish a patent airway with suction where necessary.
- · Watch for signs of respiratory insufficiency and assist ventilation as necessary.

Induction of fever occurs by action on the preoptic area of the hypothalamus to raise the set-point of the hypothalmic thermostat. The action is mediated by an endogenous pyrogen such as that produced by phagocytic leukocytes.

Treat symptomatically.

#### GENERAL FIRE HAZARDS/HAZARDOUS COMBUSTIBLE PRODUCTS

# PROCEDURE FOR HANDLING

- NOTE : Do NOT pipette by mouth. Only trained personnel should be allowed to handle or use this product.
- · Avoid all personal contact, including inhalation.
- · Wear protective clothing when risk of exposure occurs.

Empty containers may contain residual dust which has the potential to accumulate following settling. Such dusts may explode in the presence of an appropriate ignition source.

- · Do NOT cut, drill, grind or weld such containers.
- · In addition ensure such activity is not performed near full, partially empty or empty containers without appropriate workplace safety authorisation or permit.

# RECOMMENDED STORAGE METHODS

#### EYE

- For laboratory, larger scale or bulk handling or where regular exposure in an occupational setting occurs:
- · Chemical goggles
- · Face shield. Full face shield may be required for supplementary but never for primary protection of eyes
- Contact lenses may pose a special hazard; soft contact lenses may absorb and concentrate irritants. A written policy document, describing the wearing of lens or restrictions on use, should be created for each workplace or task. This should include a review of lens absorption and adsorption for the class of chemicals in use and an account of injury experience. Medical and first-aid personnel should be trained in their removal and suitable equipment should be readily available. In the event of chemical exposure, begin eye irrigation immediately and remove contact lens as soon as practicable. Lens should be removed at the first signs of eye redness or irritation lens should be removed in a clean environment only after workers have washed hands thoroughly. [CDC NIOSH Current Intelligence Bulletin 59].

#### HANDS/FEET

■ NOTE: The material may produce skin sensitization in predisposed individuals. Care must be taken, when removing gloves and other protective equipment, to avoid all possible skin contact.

Suitability and durability of glove type is dependent on usage. Important factors in the selection of gloves include: such as:

- · frequency and duration of contact,
- · chemical resistance of glove material,
- · glove thickness and
- · dexterity

Select gloves tested to a relevant standard (e.g. Europe EN 374, US F739).

- · When prolonged or frequently repeated contact may occur, a glove with a protection class of 5 or higher (breakthrough time greater than 240 minutes according to EN 374) is recommended.
- · When only brief contact is expected, a glove with a protection class of 3 or higher (breakthrough time greater than 60 minutes according to EN 374) is recommended.
- · Contaminated gloves should be replaced.

Gloves must only be worn on clean hands. After using gloves, hands should be washed and dried thoroughly. Application of a non-perfumed moisturiser is recommended.

- · Rubber gloves (nitrile or low-protein, powder-free latex). Employees allergic to latex gloves should use nitrile gloves in preference.
- · Double gloving should be considered.
- · PVC gloves.
- · Protective shoe covers.
- · Head covering.

### **OTHER**

- $\cdot$  For quantities up to 500 grams a laboratory coat may be suitable.
- · For quantities up to 1 kilogram a disposable laboratory coat or coverall of low permeability is recommended. Coveralls should be buttoned at collar and cuffs.
- · For quantities over 1 kilogram and manufacturing operations, wear disposable coverall of low permeability and disposable shoe covers.
- · For manufacturing operations, air-supplied full body suits may be required for the provision of advanced respiratory protection.
- · Eye wash unit.
- $\cdot$  Ensure there is ready access to an emergency shower.
- · For Emergencies: Vinyl suit.
- · Handle extremely poisonous natural toxins in closed systems such as glove bags or other enclosures, to avoid accidental contact. Workers should wear complete disposable clothing including shoe covers, gloves and mask with an independent air supply.

# **ENGINEERING CONTROLS**

Enclosed local exhaust ventilation is required at points of dust, fume or vapor generation.

HEPA terminated local exhaust ventilation should be considered at point of generation of dust, fumes or vapors.

### **TOXICITY AND IRRITATION**

# LIPOPOLYSACCHARIDE, SALMONELLA TYPHIMURIUM:

■ unless otherwise specified data extracted from RTECS - Register of Toxic Effects of Chemical Substances.

#### **■ WARNING:**

When injected in large quantity endotoxins produce haemorrhagic shock and severe diarrhoea. Lesser amounts cause fever, altered resistance to bacterial infection, leukopenia followed by leukocytosis and other pathology.

Bacterial lipopolysaccharides are the active components of gram-negative bacterial endotoxins and have been studied principally to elucidate pathophysiological aspects of endotoxin shock, a profound life-threatening consequence of bacterial sepsis. Endotoxins are not secreted but are released following cell disruption. They are less potent and less specific than exotoxins and do not form toxoids. The polysaccharide unit (somatic O antigen) is responsible for antigenicity and the phospholipid moiety (lipid A) is the source of toxicity.

Host-cell (e.g. B lymphocytes, macrophages) activation by lipopolysaccharide to produce functional differentiation may also be responsible for pluropotential immunostimulatory activity. Such activation may result in a cascade of hormone-active lymphokines and monokines (including interferons alpha-, beta- and gamma-, interleukins 1 and 6, tumour necrosis factor, platelet activating factor and procoagulant tissue factor). The capacity of endotoxin lipopolysaccharides and/or their active lipid A component to initiate a variety of biochemical cell activation pathways (PKC, cAMP-dependent protein kinase, arachidonate metabolism, protein myristolation and activation of G-proteins) has been exploited in the study the mechanics of cell-activation.

### WARNING:

When injected in large quantity endotoxins produce haemorrhagic shock and severe diarrhoea. Lesser amounts cause fever, altered resistance to bacterial infection, leukopenia followed by leukocytosis and other pathology.

No significant acute toxicological data identified in literature search.

Exposure to the material for prolonged periods may cause physical defects in the developing embryo (teratogenesis).

A study under different conditions of the "International Pyrogen Reference Preparation" showed that steaming for 30 minutes caused a loss of at least 52 % of activity and autoclaving at 155 deg C. for 30 minutes caused almost complete destruction. Pyrogens may be removed from solution by a strongly basic anionic-exchange resin but are generally unaffected by a strongly acid cation-exchange resin.

Legislation addressing waste disposal requirements may differ by country, state and/ or territory. Each user must refer to laws operating in

their area. In some areas, certain wastes must be tracked.

A Hierarchy of Controls seems to be common - the user should investigate:

- Reduction
- · Reuse
- · Recycling
- Disposal (if all else fails)
