Repeated or prolonged exposure may cause a bismuth line or black spots on the gums, foul breath and salivation. Exposure to bismuth may cause injury to the mouth, esophagus and stomach. Symptoms may include loss of appetite, headache, skin rash, kidney damage and jaundice.

Additional toxicological information:

To the best of our knowledge the acute and chronic toxicity of this substance is not fully known.

No classification data on carcinogenic properties of this material is available from the EPA, IARC, NTP, OSHA or ACGIH.
