Primary irritant effect:

on the skin: Corrosive effect on skin and mucous membranes.

Subacute to chronic toxicity:

Boron affects the central nervous system. Boron poisoning causes depression of the circulation, persistent vomiting and diarrhea, followed by profound shock and coma. The temperature may become subnormal and a scarletina form rash may cover the entire body. Fluorides may cause salivation, nausea, vomiting, diarrhea and abdominal pain, followed by weakness, tremors, shallow respiration, convulsions and coma. May cause brain and kidney damage. Chronic fluoride poisoning can cause severe bone changes, loss of weight, anorexia, anemia and dental defects.

Additional toxicological information:

To the best of our knowledge the acute and chronic toxicity of this substance is not fully known.

Swallowing will lead to a strong corrosive effect on mouth and throat and to the danger of perforation of esophagus and stomach.

No classification data on carcinogenic properties of this material is available from the EPA, IARC, NTP, OSHA or ACGIH.
