4. FIRST AID MEASURES

If inhaled

After contact with skin, wash with plenty of water. Gently and thoroughly wash the contaminated skin with running water and non-abrasive soap. Seek medical attention.

In case of eye contact

IMMEDIATELY flush Eyes with running water for at least 15 minutes while keeping eyes open. COLD water may be used. Seek medical attention.

If swallowed

Do not induce vomiting. Give water to victim to drink. Seek medical attention.
