4. FIRST AID MEASURES

6. ACCIDENTAL RELEASE MEASURES

Methods and materials for containment and cleaning up

7. HANDLING AND STORAGE

Precautions for safe handling

Provide appropriate exhaust ventilation at places where dust is formed. Keep away from sources of ignition - No smoking. Keep away from heat and sources of ignition.

Conditions for safe storage

Keep container tightly closed in a dry and well-ventilated place. Recommended storage temperature: -20 °C. Handle under nitrogen, protect from moisture.
