Chronic ingestion of cesium has been fatal to laboratory animals, possibly due to the replacement of potassium. Chronic exposure also can have blood and neuromuscular effects.

Additional toxicological information:

To the best of our knowledge the acute and chronic toxicity of this substance is not fully known.
