### 4. FIRST AID MEASURES

#### General advice

## 5. FIRE-FIGHTING MEASURES

### Suitable extinguishing media

## 7. HANDLING AND STORAGE

### Precautions for safe handling

Store in cool, well-ventilated area. Keep away from direct sunlight. Keep container tightly sealed until ready for use. Store at -20°C.
