Section 4 - Hazards Identification

Potential Health Effects

Eye Causes eye irritation.

Section 5 - First Aid Measures

Storage: Store in dry well ventilated place away from sources of heat and incompatible substances. Keep container tightly closed when not in use. Store at room temperature.

Eyes: Wear appropriate protective eyeglasses or chemical safety goggles as described by OSHA's eye and face protection regulations in 29 CFR 1910.133 or European Standard EN166.

Skin: Wear appropriate protective gloves to prevent skin exposure.

Respirators: Follow the OSHA respirator regulations found in 29 CFR 1910.134 or European Standard EN 149. Use a NIOSH/MSHA or European Standard EN 149 approved respirator if exposure limits are exceeded or if irritation or other symptoms are experienced.
