6. ACCIDENTAL RELEASE MEASURES

Personal precautions

Methods and materials for containment and clean up

Prevent further leakage or spillage if safe to do so. Use personal protective equipment. Cover powder spill with plastic sheet or tarp to minimize spreading and keep powder dry. Take up mechanically and collect in suitable container for disposal. Avoid dust formation. Clean contaminated surface thoroughly. Soak up with inert absorbent material. Dam up. Pick up and transfer to properly labeled containers. Sweep up and shovel into suitable containers for disposal. After cleaning, flush away traces with water. Take precautionary measures against static discharges.

Precautions for safe handling
