# BRCA1 Lentiviral Activation Particles (r): sc-437320-LAC



The Power to Overtion

#### **BACKGROUND**

The Clustered Regularly Interspaced Short Palindromic Repeats (CRISPR) and CRISPR-associated protein (Cas9) system is an adaptive immune response defense mechanism used by archea and bacteria for the degradation of foreign genetic material. This mechanism can be repurposed for other functions, including genomic engineering for mammalian systems, such as gene knockout (KO) (1,2) and gene activation (3-5). CRISPR Activation Plasmid products enable the identification and upregulation of specific genes by utilizing a D10A and N863A deactivated Cas9 (dCas9) nuclease fused to a VP64 activation domain, in conjunction with sgRNA (MS2), a target-specific sgRNA engineered to bind the MS2-P65-HSF1 fusion protein (5). This synergistic activation mediator (SAM) transcription activation system\* provides a robust system to maximize the activation of endogenous gene expression (5).

#### **CHROMOSOMAL LOCATION**

Genetic locus: Brca1 (rat) mapping to 10q23.1.

#### **PRODUCT**

BRCA1 Lentiviral Activation Particles (r) and BRCA1 Lentiviral Activation Particles (r2) are each a SAM transcription activation system designed to specifically upregulate expression of the Brca1 (rat) gene via lentiviral transduction.

BRCA1 Lentiviral Activation Particles (r) and BRCA1 Lentiviral Activation Particles (r2) each contain the following SAM activation elements: a deactivated Cas9 (dCas9) nuclease (D10A and N863A) fused to the transactivation domain VP64, an MS2-p65-HSF1 fusion protein, and a target-specific 20 nt guide RNA. They also contain blasticidin, hygromycin and puromycin resistance genes. The BRCA1 Lentiviral Activation Particles (r) and BRCA1 Lentiviral Activation Particles (r2) each encode their own, unique, target-specific 20 nt guide RNA. The resulting SAM complex provides a robust transcription activation system for the upregulation of Brca1 (rat). Each vial contains Lentiviral Activation Particles supplied frozen in 200 µl of Dulbecco's Modified Eagle Medium with 25 mM HEPES pH 7.3, containing enough virus for 10-20 transductions.

#### **APPLICATIONS**

Either BRCA1 Lentiviral Activation Particles (r) or BRCA1 Lentiviral Activation Particles (r2) is recommended for gene activation in rat cells.

#### **SUPPORT REAGENTS**

For optimal reaction efficiency with Lentiviral Activation Particle products, Polybrene®: sc-134220 (10 mg/ml) is recommended. Hygromycin B solution: sc-29067 (1 g), Blasticidin S HCl solution: sc-495389 (1 ml) and Puromycin dihydrochloride: sc-108071 (25 mg) are recommended for selection. Control Lentiviral Activation Particles: sc-437282 (200 µl) negative control is also available.

#### GENE EXPRESSION MONITORING

BRCA1 (I-20): sc-646 and BRCA1 (H-100): sc-7867 are recommended as control antibodies for monitoring of Brca1 (rat) gene expression prior to and after knockout by Western blotting (starting dilution 1:200, dilution range 1:100-1:1000) or immunofluorescence (starting dilution 1:50, dilution range 1:50-1:500).

#### **BIOSAFETY**

Lentiviral particles can be employed in standard Biosafety Level 2 tissue culture facilities (and should be treated with the same level of caution as with any other potentially infectious reagent). Lentiviral particles are replication-incompetent and are designed to self-inactivate after transduction and integration of SAM components into genomic DNA of target cells.

#### **STORAGE**

Store Lentiviral Activation Particles at -80° C. Stable for at least one year from the date of shipment. Once thawed, particles can be stored at 4° C for up to one week. Avoid repeated freeze thaw cycles.
