# IP-10 shRNA (h) Lentiviral Particles: sc-43866-V



The Power to Question

#### **BACKGROUND**

Chemokines are members of a superfamily of inducible, secreted, proinflammatory cytokines. Members of the chemokine family exhibit 20% to 50% homology in their predicted amino acid sequences and are divided into four subfamilies: C-C, C-X-C, C and C-X3-C. In the C-X-C or  $\alpha$  subfamily, the first two of four cysteine motifs are separated by another amino acid residue. In the second subfamily, designated C-C or  $\beta$ , the first cysteines are adjacent. C subfamily members, also designated  $\gamma$  chemokines, lack the first and third cysteine residues of the conserved motif. In the C-X3-C, or  $\delta$  subfamily, members have three amino acids between the two cysteines. The C-X-C chemokine subfamily includes IL-8,  $\text{GRO}\alpha/\beta/\gamma$  (and the murine homologs KC, MIP-2 $\alpha$  and MIP-2 $\beta$ ), platelet basic protein, ENA-78, GCP-2, PF4, IP-10 (and its murine homolog, CRG) and MIG.

#### **CHROMOSOMAL LOCATION**

Genetic locus: CXCL10 (human) mapping to 4q21.1.

#### **PRODUCT**

IP-10 shRNA (h) Lentiviral Particles is a pool of concentrated, transduction-ready viral particles containing 3 target-specific constructs that encode 19-25 nt (plus hairpin) shRNA designed to knock down gene expression. Each vial contains 200  $\mu$ l frozen stock containing 1.0 x 106 infectious units of virus (IFU) in Dulbecco's Modified Eagle's Medium with 25 mM HEPES pH 7.3. Suitable for 10-20 transductions. Also see IP-10 siRNA (h): sc-43866 and IP-10 shRNA Plasmid (h): sc-43866-SH as alternate gene silencing products.

#### **APPLICATIONS**

IP-10 shRNA (h) Lentiviral Particles is recommended for the inhibition of IP-10 expression in human cells.

#### **SUPPORT REAGENTS**

Control shRNA Lentiviral Particles: sc-108080. Available as 200  $\mu$ l frozen viral stock containing 1.0 x 10 $^6$  infectious units of virus (IFU); contains an shRNA construct encoding a scrambled sequence that will not lead to the specific degradation of any known cellular mRNA.

#### **GENE EXPRESSION MONITORING**

IP-10 (1): sc-101500 is recommended as a control antibody for monitoring of IP-10 gene expression knockdown by Western Blotting (starting dilution 1:200, dilution range 1:100-1:1000) or immunofluorescence (starting dilution 1:50, dilution range 1:50-1:500).

To ensure optimal results, the following support (secondary) reagents are recommended: 1) Western Blotting: use goat anti-mouse IgG-HRP: sc-2005 (dilution range: 1:2000-1:32,000) or Cruz Marker™ compatible goat anti-mouse IgG-HRP: sc-2031 (dilution range: 1:2000-1:5000), Cruz Marker™ Molecular Weight Standards: sc-2035, TBS Blotto A Blocking Reagent: sc-2333 and Western Blotting Luminol Reagent: sc-2048. 2) Immunofluo-rescence: use goat anti-mouse IgG-FITC: sc-2010 (dilution range: 1:100-1:400) or goat anti-mouse IgG-TR: sc-2781 (dilution range: 1:100-1:400) with UltraCruz™ Mounting Medium: sc-24941.

#### **RT-PCR REAGENTS**

Semi-quantitative RT-PCR may be performed to monitor IP-10 gene expression knockdown using RT-PCR Primer: IP-10 (h)-PR: sc-43866-PR (20  $\mu$ l). Annealing temperature for the primers should be 55-60° C and the extension temperature should be 68-72° C.

#### **BIOSAFETY**

Lentiviral particles can be employed in standard Biosafety Level 2 tissue culture facilities (and should be treated with the same level of caution as with any other potentially infectious reagent). Lentiviral particles are replication-incompetent and are designed to self-inactivate after transduction and integration of shRNA constructs into genomic DNA of target cells.

#### **STORAGE**

Store lentiviral particles at -80° C. Stable for at least one year from the date of shipment. Once thawed, particles can be stored at 4° C for up to one week. Avoid repeated freeze thaw cycles.
