# Jagged1 shRNA (m2) Lentiviral Particles: sc-44336-V



The Power to Question

#### **BACKGROUND**

The LIN-12/Notch family of transmembrane receptors is believed to play a central role in development by regulating cell fate decisions. Ligands for Notch include Jagged1, Jagged2 and Delta. Jagged is a membrane protein and can activate Notch and prevent myoblast differentiation by inhibiting the expression of muscle regulatory and structural genes. It is involved in mammalian cardiovascular development and in cell-fate decisions during hematopoiesis. Jagged is expressed in adult and fetal tissues, and expression is upregulated in cervical squamous cell carcinoma. Familial Tetralogy of Fallot, the most common form of complex congenital heart disease, is caused by a mutation in the Jagged1 gene.

#### **CHROMOSOMAL LOCATION**

Genetic locus: Jag1 (mouse) mapping to 2 F3.

#### **PRODUCT**

Jagged1 shRNA (m2) Lentiviral Particles is a pool of concentrated, transduction-ready viral particles containing 3 target-specific constructs that encode 19-25 nt (plus hairpin) shRNA designed to knock down gene expression. Each vial contains 200  $\mu$ l frozen stock containing 1.0 x 10 $^6$  infectious units of virus (IFU) in Dulbecco's Modified Eagle's Medium with 25 mM HEPES pH 7.3. Suitable for 10-20 transductions. Also see Jagged1 siRNA (m2): sc-44336 and Jagged1 shRNA Plasmid (m2): sc-44336-SH as alternate gene silencing products.

#### **STORAGE**

Store lentiviral particles at -80° C. Stable for at least one year from the date of shipment. Once thawed, particles can be stored at 4° C for up to one week. Avoid repeated freeze thaw cycles.

#### **APPLICATIONS**

Jagged1 shRNA (m2) Lentiviral Particles is recommended for the inhibition of Jagged1 expression in mouse cells.

#### **SUPPORT REAGENTS**

Control shRNA Lentiviral Particles: sc-108080. Available as 200  $\mu$ l frozen viral stock containing 1.0 x 10 $^6$  infectious units of virus (IFU); contains an shRNA construct encoding a scrambled sequence that will not lead to the specific degradation of any known cellular mRNA.

#### **GENE EXPRESSION MONITORING**

Jagged1 (C-20): sc-6011 is recommended as a control antibody for monitoring of Jagged1 gene expression knockdown by Western Blotting (starting dilution 1:200, dilution range 1:100-1:1000) or immunofluorescence (starting dilution 1:50, dilution range 1:50-1:500).

To ensure optimal results, the following support (secondary) reagents are recommended: 1) Western Blotting: use donkey anti-goat IgG-HRP: sc-2020 (dilution range: 1:2000-1:100,000) or Cruz Marker™ compatible donkey anti-goat IgG-HRP: sc-2033 (dilution range: 1:2000-1:5000), Cruz Marker™ Molecular Weight Standards: sc-2035, TBS Blotto A Blocking Reagent: sc-2333 and Western Blotting Luminol Reagent: sc-2048. 2) Immunofluorescence: use donkey anti-goat IgG-FITC: sc-2024 (dilution range: 1:100-1:400) or donkey anti-goat IgG-TR: sc-2783 (dilution range: 1:100-1:400) with UltraCruz™ Mounting Medium: sc-24941.

#### **RT-PCR REAGENTS**

Semi-quantitative RT-PCR may be performed to monitor Jagged1 gene expression knockdown using RT-PCR Primer: Jagged1 (m2)-PR: sc-44336-PR (20  $\mu$ l). Annealing temperature for the primers should be 55-60° C and the extension temperature should be 68-72° C.

#### **BIOSAFETY**

Lentiviral particles can be employed in standard Biosafety Level 2 tissue culture facilities (and should be treated with the same level of caution as with any other potentially infectious reagent). Lentiviral particles are replication-incompetent and are designed to self-inactivate after transduction and integration of shRNA constructs into genomic DNA of target cells.
