# PP5 shRNA (m) Lentiviral Particles: sc-44603-V

## BACKGROUND

In eukaryotes, the phosphorylation and dephosphorylation of proteins on serine and threonine residues is an essential means of regulating a broad range of cellular functions including division, homeostasis and apoptosis. A group of proteins that are intimately involved in this process are the protein phosphatases. In general, the protein phosphatase (PP) holoenzyme is a trimeric complex composed of a regulatory subunit, a variable subunit and a catalytic subunit. Four major families of protein phosphatase catalytic subunit have been identified, designated PP1, PP2A, PP2B and PP2C. An additional protein phosphatase catalytic subunit, PPX (also known as PP4), is a putative member of a novel PP family. PP5, also designated protein phosphatase T (PP-T, PPP5C), a predominantly nuclear protein which belongs to the PPP phosphatase family and the PP-T subfamily, interacts with CDC16 and CDC27. It dephosphorylates serine residues of skeletal muscle phosphorylase and Histone H1 and may be involved in mitosis and RNA biogenesis regulation.

## CHROMOSOMAL LOCATION

Genetic locus: Ppp5c (mouse) mapping to 7 A2.

## PRODUCT

PP5 shRNA (m) Lentiviral Particles is a pool of concentrated, transduction-ready viral particles containing 3 target-specific constructs that encode 19-25 nt (plus hairpin) shRNA designed to knock down gene expression. Each vial contains 200  $\mu$ l frozen stock containing  $1.0 \times 10^6$  infectious units of virus (IFU) in Dulbecco's Modified Eagle's Medium with 25 mM HEPES pH 7.3. Suitable for 10-20 transductions. Also see PP5 siRNA (m): sc-44603 and PP5 shRNA Plasmid (m): sc-44603-SH as alternate gene silencing products.

## STORAGE

Store lentiviral particles at  $-80^{\circ}$  C. Stable for at least one year from the date of shipment. Once thawed, particles can be stored at  $4^{\circ}$  C for up to one week. Avoid repeated freeze thaw cycles.

## APPLICATIONS

PP5 shRNA (m) Lentiviral Particles is recommended for the inhibition of PP5 expression in mouse cells.

## SUPPORT REAGENTS

Control shRNA Lentiviral Particles: sc-108080. Available as 200  $\mu$ l frozen viral stock containing  $1.0 \times 10^6$  infectious units of virus (IFU); contains an shRNA construct encoding a scrambled sequence that will not lead to the specific degradation of any known cellular mRNA.

## GENE EXPRESSION MONITORING

PP5 (G-6): sc-515257 is recommended as a control antibody for monitoring of PP5 gene expression knockdown by Western Blotting (starting dilution 1:200, dilution range 1:100-1:1000) or immunofluorescence (starting dilution 1:50, dilution range 1:50-1:500).

To ensure optimal results, the following support (secondary) reagents are recommended: 1) Western Blotting: use goat anti-mouse IgG-HRP: sc-2005 (dilution range: 1:2000-1:32,000) or Cruz Marker<sup>™</sup> compatible goat anti-mouse IgG-HRP: sc-2031 (dilution range: 1:2000-1:5000), Cruz Marker<sup>™</sup> Molecular Weight Standards: sc-2035, TBS Blotto A Blocking Reagent: sc-2333 and Western Blotting Luminol Reagent: sc-2048. 2) Immunofluorescence: use goat anti-mouse IgG-FITC: sc-2010 (dilution range: 1:100-1:400) or goat anti-mouse IgG-TR: sc-2781 (dilution range: 1:100-1:400) with UltraCruz<sup>™</sup> Mounting Medium: sc-24941.

## RT-PCR REAGENTS

Semi-quantitative RT-PCR may be performed to monitor PP5 gene expression knockdown using RT-PCR Primer: PP5 (m)-PR: sc-44603-PR (20  $\mu$ l). Annealing temperature for the primers should be  $55-60^{\circ}$  C and the extension temperature should be  $68-72^{\circ}$  C.

## BIOSAFETY

Lentiviral particles can be employed in standard Biosafety Level 2 tissue culture facilities (and should be treated with the same level of caution as with any other potentially infectious reagent). Lentiviral particles are replication-incompetent and are designed to self-inactivate after transduction and integration of shRNA constructs into genomic DNA of target cells.
